

# FILING OF DOCUMENTS RELATING TO THE TRANSLISTING TO MTA – ITALIAN EQUITIES MARKET

*Arzignano (VI), April 29th, 2020* - **SICIT Group S.p.A.** (the "**Company**") announces that it filed, yesterday, with the Italian Companies and Stock Exchange Commission ("CONSOB") the documentation functional to the admission to trading of the Company's ordinary shares and warrants on Mercato Telematico Azionario (MTA – Italian Equities Market), possibly STAR segment (the "**Listing**"), organised and managed by Borsa Italiana, as part of the administrative procedure started by CONSOB (still in progress) and relating to the application for approval of the listing prospectus. The prospectus, together with further documentation related to the resolutions approved by the Shareholders' Meeting of April 20th, 2020 was also filed with Borsa Italiana.

It is expected that, compatibly and subject to the completion of CONSOB and Borsa Italiana's investigations, the translisting to Mercato Telematico Azionario may take place indicatively by the end of the first half of 2020.

It should be noted that as part of the above-mentioned listing project, the Company appointed Banca IMI S.p.A. as Sponsor and Specialist in accordance with the Regulations of the Markets organised and managed by Borsa Italiana to carry out the activities provided for therein.

The Company has also passed the necessary and appropriate *governance* resolutions, for which reference should be made to the press releases dated April 20<sup>th</sup> and March 26<sup>th</sup> and 16<sup>th</sup>, 2020 available on the website <u>www.sicitgroup.com</u>, "*Investor Relations*" Section.
